THE HARINGEY (CONTROLLED PARKING ZONES) (AMENDMENT NO. 1) ORDER 2018

Made: 29th March 2018

Coming into force: 3rd April 2018

The Council of the London Borough of Haringey, after consulting the Commissioner of Police of the Metropolis in exercise of the powers conferred by sections 45, 46 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984(a) and of all other enabling powers, hereby make the following Order:-

1. This Order may be cited as the Haringey (Controlled Parking Zones) (Amendment No. 1) Order 2018 and shall come into force on 3rd April 2018.
2. In this Order –
 - (a) the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;
 - (b) the "Orders(A)" means The Haringey (Bounds Green East CPZ) (Designations) Order 2018, The Haringey (Woodside West CPZ) (Designations) Order 2018, The Haringey (White Hart Lane CPZ) (Designations) Order 2018, The Haringey (Alexandra Palace CPZ) (Designations) Order 2015, The Haringey (Highgate Station CPZ) (Designations) Order 2013, The Haringey (Highgate Station Outer CPZ) (Designations) Order 2013, The Haringey (Highgate A CPZ) (Designations) Order 2013, The Haringey (St. Ann's CPZ) (Designations) Order 2014, The Haringey (Tottenham CPZs) (Designations) Order 2015, The Haringey (Wood Green CPZ) (Parking Places) Consolidation Order 2013, The Haringey (Woodside CPZ) (Designations) Order 2015 and The Haringey (Hornsey South CPZ) (Designations) Order 2014;

 - (d) the "Orders(C)" means The Haringey (Fortis Green Area CPZ) (Parking Places) Order 2007, The Haringey (Bruce Grove CPZ) (Parking Places) Order 2007 and The Haringey (Green Lanes CPZ) (Parking Places) Order 2007.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Orders(A) shall have effect as though:-
 - (a) the sub-paragraph numbered (4)(a)(ii) to Article 14 were omitted;
 - (b) the paragraph numbered (8) to Article 15 were omitted;
 - (c) for the sub-paragraph numbered (4)(a)(i) to Article 14 there were substituted the sub-paragraph similarly numbered and set out below:-

Refund of fee paid in respect of a permit

21(1) A permit holder who surrenders a permit to the Council or authorised agent before the permit becomes valid shall be entitled to a refund of the fee paid in respect thereof.

(2) A permit holder who surrenders a permit to the Council or authorised agent after the permit has become valid shall be entitled to a refund of part of the fee paid in respect thereof in accordance with the provisions of the next following paragraph.

(3) The part of the fee which is refundable under the provisions of the last foregoing paragraph shall be calculated as -

- (a) in the case of a permit issued under the provisions of Article 17(3), one twelfth of the amount specified in Article 15(4) in respect of each complete month of the period specified thereon as the period during which it shall be valid which remains unexpired at the time when the permit is surrendered to the Council or authorised agent; or
- (b) in the case of a permit issued under the provisions of Article 18(5):
- (j) in respect of each complete month of the period specified thereon as the period during which it shall be valid which remains unexpired at the time when the permit is surrendered to the Council or authorised agent and £11.80 administration charge will apply to a refund;
- (c) in the case of a permit issued under the provisions Article 27:
- (i) any charge paid in respect of a special parking permit that is surrendered before it becomes valid;
- (ii) after it becomes valid, a refund of any charge paid in respect thereof but the amount of any refund (if any) shall be at the discretion of the Council's appropriate delegated authority.
